Mahindra First Plans to Sell Stake to Raise Up to ₹250 cr

Mumbai: Mahindra First Choice Services, the used car services arm of Mahindra & Mahindra, plans to sell a part of its stake to raise up to ₹250 crore and invest the proceeds in a startup whereby it plans to aggregate car servicing centres. The company is in the process of engaging an investment banker for fundraising and will be reaching out to venture capital and PE investors to sell a stake, people in the know said. The aim is to close a deal in 3-6 months. The funds will be used in a portal, Carworkz, which is currently being tested and is set to go on stream shortly. Mahindra First Choice has floated a fully-owned subsidiary, Autodi-

gitech. The firm is open to a VC fund putting money in Autodigitech, which will operate the Carworkz portal, or a PE investing in Mahindra First Choice.

Mahindra First Choice Services CEO YVS Vijay Kumar confirmed the fundraising plan. He said that the company needed ₹250 crore to launch a "brick and click" model.

"The company will be running Autodigitech or Carworkz as a true startup idea. We have studied the model in other industries. Through Carworkz, we will offer booking, reviews, rating, etc.," he said. It is launching a website and app, which will provide info to clients, including on the facilities at the service centres in their neighbourhood and the cost estimate.
