He mentioned that the program participants have a diverse and rich industrial experience ranging from three to twenty-seven years in various sectors such as Banking, E-Commerce, FMCG, Healthcare, IT & ITES, Manufacturing, Telecom, Hospitality, Education & Training, and many others.

Prof. Mohit Goswami, Chairman E-learning, addressed that traditional models of business are getting disrupted day by day and are subject to changes and challenges. He stated that countries are shifting their focus from globalisation business models and are focusing more on developing their inward capabilities. He further added that people, from students to professionals, need to

augment their skills, and SMAC (Social, mobile, analytics, and cloud) can help drive this.

Prof. Bharat Bhasker, Director, IIM Raipur, welcomed the 2nd batch of the program and shared encouraging messages with the participants. He emphasized that thousands of management professionals are required to boost the economy of the country. He also mentioned the objective of the program is to prepare the participants about the nuances of how the global economy operates and to guide them to leverage this knowledge to the country's advantage.
